Special and/or sensitive personal data that we process

For what purpose and on what basis we process personal data

Automated decision making

How long do we keep personal data

- Location data > 24 months> Analysing data via Google Analytics (anonymous)
- Data about your activities on our website> 24 months> Analysing data via Google Analytics (anonymous)
- Internet browser and device type> 24 months> Analysing data via Google Analytics (anonymous)

Payment details

Bank account number > 12 - 60 months> Legal obligation for taxes and invoicing.

- First and last name > 24 months> Database data to contact you for updates.
- Email address > 24 months > Database data to contact you for updates.

Sharing of personal data with third parties

Kubuni only provides to third parties; and only if this is necessary; for the implementation of our agreement with you, or to comply with a legal obligation.

Cookies, or similar techniques, that we use

Kubuni uses functional, analytical and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website. Kubuni uses cookies with purely technical functionality. These ensure that the website works properly and that, for example, your preferred settings are remembered. These cookies are also used to make the

website work properly and to optimize it. In addition, we place cookies that track your surfing behavior so that we can offer customized content and advertisements.

On your first visit to our website, we have already informed you about these cookies and have asked permission to place them.

You can opt out of cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information that was previously saved via the settings of your browser.

View, modify or delete data

You have the right to view, correct or delete your personal data. Make in this copy your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen service number (BSN) black. This is to protect your privacy. We will respond to your request as quickly as possible, but within four weeks.

How we protect personal data

Anti-malware programs & security certification on the website. Files not accessible to third parties, and secured under contract.

- TLS (formerly SSL) We send your data via a secure internet connection. You can see this on the address bar 'https' and the padlock in the address bar.
- -DNSSEC is an additional security (in addition to DNS) for converting a domain name (#company_website) to the associated IP address (server name); it is provided with a digital signature. You can have that signature checked automatically. In this way we prevent you being redirected to a false IP address.
